Set Free Ranch Twentynine Palms

Hello – my name is Pastor Nick Foley and I am the senior pastor of Set Free Church - Wonder Valley (fka Wonder Valley Community Church). My family and I are very excited to share with you the vision God gave us in reaching the lost in Wonder Valley/Twentynine Palms. It began with my pastor, Pastor Martin Souter, meeting with my wife and I in December of 2021 to discuss expanding the Set Free Ranch Ministry to the high desert. We prayed and received confirmation from the Lord and relocated our family from Needles, California to Wonder Valley on January 28, 2022 and held our first service the following Sunday.

Set Free Ranch History

Set Free Ranch formed in 1994 in Cabazon, California by Willie Dalgity. The ranch provides men with the tools necessary to maintain their sobriety and build a solid foundation with the Almighty. Our objectives go beyond getting men off the streets, getting sober and building a productive member of society. Our intentions and desire is to introduce men to Jesus and to grant them the opportunity to experience the kingdom of God here on earth. Over the years, thousands of individuals have benefitted from the 3-phase program and surrendered their lives to Christ. Set Free Ranch sites located in California include: Needles, Lake Elsinore, Phelan and Wonder Valley. The ranch is a place where men encounter Jesus like never before and prayerfully walk the rest of their lives with Him.

Due to the overwhelming need of addiction recovery in this area, the Wonder Valley site has reached maximum capacity and we have an opportunity to relocate the ranch to Twentynine Palms. The location includes 28 acres with 7 structures (see photos), which can house up to 26 men. The property has everything needed to accommodate our 3-phase program and the owner is interested in renting to us for the purpose of reaching men for Christ and rehabilitating them. After meeting with Pastor Luz, property owner, I know this is a divine opportunity that has been brought to our attention by God to expand the development of our mission.



Phase 1, 2, 3

Phase 1: 60-day blackout period. During this time, men will focus on remaining sober and learning to develop a relationship with Jesus by attending daily mandatory, meticulous group scheduled classes that are based on teachings directly from the Bible. After the 60 days are completed, men are given the option to remain in the program and move on to the next phase or go home to their families.

Phase 2: 6-8 month commitment. Men will begin engaging and actively participating within the community and operating through “work blessings”. The same structure from Phase 1 will still apply but with more leisure.

Work Blessings: Donations to the ministry are received for services performed: yard work, landscaping, trash removal, moving jobs, flooring, serving, cleaning, etc. We have many testimonials, including Councilmember McArthur Wright for the City of Twentynine Palms, who used our services and has been pleased with the results. He also will be attending and sharing at the open house. To schedule a service, please contact me at 760-258-5170. We do not give estimates.

Phase 3: During this period we will assess the men and determine if they would like to continue within the church or through employment.

Operating Expense/Lease (\$18k per month / Lease period: January 1, 2024 - December 31, 2024)

Set Free Church – Wonder Valley is a 501c3 nonprofit organization and is seeking financial partners to support the ministry in reaching men bound by addiction. We are committing to a 1-year lease to start the process. Details will be shared at the open house.
